In accordance with the current and applicable regulations on the Protection of Personal Data, General Data Protection Regulation (GDPR) 2016/679, Organic Law 3/2018 of December 5, on the protection of personal data and guarantee of digital rights (LOPDGDD), and Law 34/2002, of July 11, on Information Society Services and Electronic Commerce (LSSI-CE), ELMEGA SL informs users that it has created a profile on the Social Networks Facebook, Twitter, Instagram, primarily for advertising its products and services.

ELMEGA SL has access to and processes the user's public information, especially their contact name, within the Social Network. This data is only used within the Social Network and is not incorporated into any processing system.

Regarding the rights of access, rectification, limitation of processing, erasure, portability, and objection to the processing of your personal data that you have and can be exercised before ELMEGA SL, in accordance with the GDPR, you should consider the following nuances:

- Right of Access: It is the user's right to obtain information about their specific personal data and the processing that has been or will be carried out, as well as information available on



the origin of such data and the communications made or planned with them.

- **Right to Rectification:** It is the right of the data subject to have inaccurate or incomplete data modified. It can only be satisfied in relation to information under the control of ELMEGA SL, for example, deleting comments published on the page itself, images, or web content containing the user's personal data.
- **Right to Limitation of Processing:** It is the right to limit the originally intended purposes of the processing by the data controller.
- **Right to Erasure:** It is the right to erase the user's personal data, except as provided for in the GDPR itself or in other applicable regulations that determine the obligation to retain such data, in terms of time and form.
- **Right to Data Portability:** The right to receive the personal data provided by the user in a structured, commonly used, and machine-readable format, and to transmit them to another controller.
- **Right to Object:** It is the user's right to object to the processing of their personal data or to have ELMEGA SL cease processing them.

ELMEGA SL will carry out the following actions:

- Access to the user's profile's public information.
- Publication on the user's profile of all information already published on the ELMEGA SL page.
- Sending personal and individual messages through the Social Network's channels.
- Updates of the page's status that will be published on the user's profile.

The user can always control their connections, delete content that is no longer of interest, and restrict with whom they share their connections by accessing their privacy settings.

POSTS

Once joined to the ELMEGA SL page, the user can publish comments, links, images, or any other type of multimedia content supported by the Social Network. The user must be the owner of the content, have the copyright and intellectual property rights, or have the consent of the affected third parties. Any publication on the page that violates morality, ethics, good taste, or decency, and/or infringes, violates, or breaches intellectual or industrial property rights, the right to image, or the Law is expressly prohibited. In such cases, ELMEGA SL reserves the right to immediately remove the content and may request the permanent blocking of the user.



ELMEGA SL will not be responsible for the content freely published by a user. The user should be aware that their posts will be known by other users, so they are primarily responsible for their privacy. Images published on the page will not be stored in any processing system by ELMEGA SL but will remain on the Social Network.

The rules of each contest, when the Social Network platform is used for this purpose, will be published therein, always complying with the LSSI-CE and any other applicable regulations.
